A huge thank you to our wait staff and bartenders for diligently checking the cards to assist in getting all members paid current. We are slowly inching down our delinquencies, and now only have 25 delinquent members. We would like to eliminate all delinquencies as soon as possible, in order to have a gain in membership this year. It has been a long time coming. Last year, Virginia Elks Association had a membership gain overall of 27. The Grand Lodge reported a membership gain for the first time in 30 years! Let's keep the momentum going. As a "Head's Up" our dues will be increased slightly this year, as the Grand Lodge assessment has increased by \$2.00 and the Virginia Elks Association assessment was also increased. The dues notices will be going out in late January or early February.

GUIDELINES FOR LODGE E-BLASTS (ELECTRONIC NEWS FLASHES)

In order to simplify sending notices to our members online concerning Club and Lodge events, and to end confusion from misinformation being sent, we have put the following procedures in place:

- (1) One person per event should be designated as the "spokesperson" and that person should contact the Secretary of the Lodge (Jan Sullivan) concerning the eblast, with a copy to Rose Thiebaut.
- (2) The request needs to be written out completely and accurately and then sent to the Secretary as soon as the event is scheduled and marked on the Lodge calendar, and the details are in place.
- (3) The Secretary (or Rose Thiebaut in Jan's absence) will respond to the spokesperson that the message has been received. If there is no response within a 24-hour period, please call.
- (4) The Secretary and her press team will be the only ones responsible for getting the message out. The event organizers are responsible for coordinating with the Exalted Ruler, the Club Manager, and the House and Entertainment Committees concerning staffing, food, times, etc.
- (5) If there is a change, the Secretary should be notified as quickly as possible with the new details.

If you have not met our new **Club Manager John Hyde**, please stop by to introduce yourself. John is a VCU grad and Fairfax resident with 15+ years of restaurant management experience. He also holds the designation of certified wine specialist from the Guild of Sommeliers. John has made improvements to our POS and inventory systems and has some great ideas for improving the food and beverage experience for our members and guests. Watch for new member events in the Lounge, including new happy hour specials, Trivia and Guest Chef Night!

As most of you know, the Board oversees the Club/dining and event rental operations. For the 6-month period of April-September 2019, Club gross profit is outperforming budget at \$280,000 and our food/beverage/labor costs are all meeting the Grand Lodge targets for the first time in many years.

The Board also oversees facility maintenance and has recently completed urgent HVAC upgrades and roofing repairs, as well as other painting and repair needs throughout the Lodge. By the time you read this article we should be in the final stages of projects to renovate the downstairs men's and handicap restrooms and replace our aging dining room chairs. Next up on our agenda includes working with the Decorating Committees and other interested members to address flooring concerns throughout the Lodge, various door repairs/upgrades, lobby renovations, lighting and (of course) the Tiki Bar! Future projects include improving our RV area, stages, and resurfacing the parking lot. **The Board of Trustees invite all interested members to attend our meetings which are usually the 1st and 3rd Tuesdays of each month at 7:00 p.m. Our email addresses are in this newsletter and we appreciate your suggestions on any matters concerning the Club and facilities. Please come to the meetings and participate in the discussions on the projects.**

Meet Venture Crew #2188



Venture Crew #2188 is a new scouting unit that is chartered (supported) by our Elks Lodge. Venture Crew 2188 has 15 members - 12 boys and 3 girls ages 14-20 -- and it is a subset of the Mantua Troop #1533 that has been meeting at our Lodge for the past few years.

Venturing is a BSA program built around the "ALPS Model"

- A - Adventure** - Mentoring, leading and participating in crew-led adventures
- L - Leadership** - Ongoing leadership development through training, mentoring, and hands-on leadership.
- P - Personal Growth** – Goal setting in support of personal growth.
- S - Service** - Leading and participating in community service.

Elks Launch Campaign to Support Pearl Harbor

They wondered if the Elks could play a part in helping to improve this memorial. That idea soon became reality, and the Elks are now partnering with the Pacific Historical Parks, a WWII focused 501(c)(3) tax-exempt public benefit organization that oversees the Pearl Harbor National Memorial.

With contributions from Elks across the country, we can preserve, restore and modernize the USS Arizona Memorial. All funds raised will be used to:

- Replace old, faded and peeling outdoor exhibits along Pearl Harbor National Memorial's perimeter.
- Upgrade current static displays with digital exhibits, build new interactive displays to engage children, and modernize the Pearl Harbor museums with iPads and touch screens.
- Fabricate and install new exhibits, displays, programs, and software to better educate and serve all museum visitors.

Our ultimate goal is to raise \$783,000, or a dollar per member, to truly help preserve history, perpetuate peace and reconciliation, and ensure that the memories of our veterans, passed and living, are never forgotten. **As of November 12, Elks have donated \$29,733 for this cause!**

These contributions will help honor the service and dedication of Americans whose profound contributions to our nation should never be forgotten, so that generations to come will know and appreciate the enormous sacrifices of the Greatest Generation.
